Membership Agreement

Please thoroughly read this Membership Agreement and the Membership Conduct and Club Regulations. Then complete, initial each page and sign the Membership Agreement and return it with your Membership Initiation Fee payment by mailing it to:

1. By signing below, I agree that, if my application for membership is accepted, notwithstanding the use of the term "member" or the term "club", I am a sub-licensee of the American Fish and Game Club (the "AFGC") under its licenses to use the various water bodies and land which will be available to me for hunting and fishing purposes, pursuant to Fishing & Hunting Leases between the AFGC, or its predecessor, successor, assignor, or assignee, and the various owners of the land (the "Landowners") on which the properties are located. I agree that the Fishing & Hunting Leases are for differing terms and that the availability of various water bodies and land may change or that specific water bodies and land may become unavailable during the term of the agreement. I agree that this application is in the nature of an offer to the AFGC under which, if accepted, I will become a sub-licensee as specified above.

2. I agree that the term of this agreement shall be one year from the date of acceptance set forth below and that upon acceptance of my payment of the renewal fee in effect at that time, the term of this agreement shall renew for another year upon the same terms and conditions.

3. I agree to abide by all terms of this Membership Agreement, as well as by the Membership Conduct and Club Regulations. I agree that if the AFGC determines that I have violated this agreement or any of the regulations set forth on the reverse hereof, it can terminate this agreement and my rights as a sub-licensee, without reimbursement to me of any funds which I previously have paid.

4. RELEASE OF LIABILITY AND ASSUMPTION OF RISK. In consideration of being allowed to use the various water bodies and land of the AFGC for fishing or hunting I HEREBY ACKNOWLEDGE ON BEHALF OF MYSELF AND MY MINOR CHILD, IF APPLICABLE, THAT THE RISK OF INJURY RELATING TO PERFORMANCE OF THIS AGREEMENT AND MY VISIT TO OR USE OF THE WATER BODIES AVAILABLE TO ME AS A SUB-LICENSEE OF THE AFGC IS SIGNIFICANT, INCLUDING THE POTENTIAL FOR PERMANENT DISABILITY AND DEATH. ON BEHALF OF MYSELF AND MY MINOR CHILD, IF APPLICABLE, I KNOWINGLY AND VOLUNTARILY ASSUME SUCH RISKS, BOTH KNOWN AND UNKNOWN, EVEN IF ARISING FROM THE NEGLIGENCE OF THE AFGC AND ITS AGENTS, EMPLOYEES, ATTORNEYS, OFFICERS, AND DIRECTORS (THE RELEASED PARTIES). ON BEHALF OF MYSELF AND MY MINOR CHILD, IF APPLICABLE, I HEREBY FURTHER AGREE TO AND DO **[INITIAL: _____]**

RELEASE, HOLD HARMLESS, AND INDEMNIFY AND AGREE TO DEFEND THE LAND-OWNERS AND THE AFGC AND ITS AGENTS, EMPLOYEES, ATTORNEYS, OFFICERS, AND DIRECTORS (THE RELEASED PARTIES) FROM AND AGAINST ANY AND ALL DAMAGES, CLAIMS, DEMANDS, OR EXPENSES, INCLUDING CLAIMS FOR WRONGFUL DEATH, PERSONAL AND BODILY INJURY (INCLUDING PERMANENT DISABILITY OR PARALYSIS), OR PROPERTY DAMAGE, RELATING TO OR RESULTING FROM ANY OF THE FOLLOWING: (1) THE ORDINARY OR GROSS NEGLIGENCE OR WILLFUL MISCONDUCT OF ME OR ANY OF THE RELEASED PARTIES, (2) ANY INTENTIONAL TORT COMMITTED BY ME OR ANY OF THE RELEASED PARTIES, (3) ANY STRICT LIABILITY THEORY UNDER WHICH I OR ANY OF THE RELEASED PARTIES MIGHT BE LIABLE FOR SUCH DAMAGES, CLAIMS, DEMANDS OR EXPENSES, OR (4) PERFORMANCE OF THIS AGREEMENT BY ME OR THE AFGC, INCLUDING MY UTILIZATION OF, AND FISHING OR HUNTING UPON, THE VARIOUS WATER BODIES AND LAND AVAILABLE TO ME AS A SUB-LICENSEE OF THE AFGC. Each instance of my visit to or use of any of the water bodies or land of the AFGC shall constitute my ratification and re-affirmation of the previous provision releasing, holding harmless, indemnifying, and agreeing to defend the Released Parties. ON BEHALF OF MYSELF AND MY MINOR CHILD, IF APPLICABLE, I FURTHER AGREE THAT I WILL NOT SUE OR MAKE ANY CLAIM AGAINST ANY LANDOWNERS OR ANY INDIVIDUAL, ENTITY, OR GROUP INVOLVED WITH THE AFGC NOW OR IN THE FUTURE CONCERNING ANY INJURY OR DAMAGE (INCLUDING WRONGFUL DEATH, PERSONAL INJURY OR PROPERTY DAMAGE) RELATING TO OR RESULTING FROM PERFORMANCE UNDER THIS AGREEMENT OR MY USE OF, AND FISHING UPON, THE WATER BODIES OR LAND AVAILABLE TO ME AS A SUB-LICENSEE OF THE AFGC. On behalf of myself and my minor child, if applicable, I hereby waive the right to any notice of defects, latent or patent, or dangerous conditions, reasonable or unreasonable, which may exist upon any water bodies or land. I also agree that, notwithstanding the termination or expiration of the term of this agreement, the covenants herein to indemnify, hold harmless, defend and release the Released Parties shall expressly survive the termination of this agreement, the same are severable, and that but for my agreement to indemnify, hold harmless, defend and release certain parties as set forth herein, the American Fish and Game Club would not accept the offer represented by this application.

FOR MYSELF AND MY MINOR CHILD, IF APPLICABLE, I HAVE READ THIS MEMBERSHIP AGREEMENT AND AGREE TO ABIDE BY ITS TERMS. I FURTHER STATE THAT I UNDERSTAND THE PROVISIONS OF THE MEMBERSHIP AGREEMENT, INCLUDING SECTION 4 (RELEASE OF LIABILITY AND ASSUMPTION OF RISK) IN WHICH I, ON BEHALF OF MYSELF AND MY MINOR CHILD, IF APPLICABLE, HAVE GIVEN UP MY RIGHT TO SUE AS DESCRIBED IN THAT SECTION.
